Requirements and Policies:

A 50% deposit (based on estimated cost) is due at time reservation is made. Final cost will be determined upon your groups arrival. Balance due will be paid upon check-in. The deposit is fully refundable sixty (60) days prior to the event; 50% refundable thirty (30) days prior to the event; and non-refundable less than 30 days prior to the event. **Events ending after 8:30 pm will incur a \$500 lighting fee.**
Inclement Weather: In the event that inclement weather prevents the park from hosting your event, Splash Kingdom will work with your group to reschedule the event or provide a full refund of the amount paid. If inclement weather causes the park to close prior to completing at least 75% of the scheduled time of your event, Splash Kingdom will choose from the following options in order to accommodate your group: (a) Prorate the total cost of the event accordingly or (b) reactivate group tickets to be used anytime during the current season.
